MOLINE CITY COUNCIL MEETING

Tuesday, February 15, 2022

Council Meeting: The City Council meeting came to order at 7:00 p.m. The Council met in regular session in the Council Chambers at City Hall.

Pledge: The Council and audience recited the Pledge of Allegiance.

Invocation: There was no Invocation.

Roll Call: Roll call was taken with Mayor Rayapati, Aldermen Williams, Macias, Wendt, Timion, Moyer, O'Brien, Waldron and Schmidt present. Absent: None.

Resolutions

1. Council Bill/Resolution 1024-2022

A Resolution authorizing the Mayor and Chief of Police to execute an Equitable Sharing Agreement and Certification between the Federal Government and the Moline Police Department setting forth the requirements for participation in the Equitable Sharing Program and certifying all receipts and expenditures of federal forfeiture funds, property and interest during the last fiscal year.

2. Council Bill/Resolution 1025-2022

A Resolution authorizing the City of Moline Community Development Block Grant Policies and Procedures Manual.

3. Council Bill/Resolution 1026-2022

A Resolution authorizing the Mayor and City Clerk to execute and attest to an agreement with Express Services, Inc., doing business as Express Employment Professionals, to provide administrative services to fulfill temporary and seasonal staffing needs of City departments and also provide the insurance and liability coverage requested for a one-year period commencing March 1, 2022.

4. Council Bill/Resolution 1027-2022

A Resolution authorizing the Information Technology Manager to purchase seven (7) Panasonic Toughbooks from CDS Office Technologies in the amount of \$23,991.

5. Council Bill/Special Ordinance 4001-2022

A Special Ordinance granting a permanent waiver to Section 28-3200(a) and Section 35-4218, of the Moline Code of Ordinances, and a \$9,984 payment into the sidewalk fund in-lieu of construction of sidewalk along 10th Avenue, for property located at 1002 27th Street, Moline.

Adopted. Alderman Timion, seconded by Alderman Moyer, moved to adopt Council Bill 4001-2022. Motion carried on roll call with the following vote: ayes: Aldermen Macias, Wendt, Timion, Moyer, O'Brien, Waldron, Schmidt and Williams; nays: none.
