AN ORDINANCE

AMENDING Chapter 2, "ADMINISTRATION", Article IV, "BOARDS AND COMMISSIONS", Division I, "IN GENERAL", Section 2-4100, LIST OF BOARDS AND COMMISSIONS", Subsection (e), "EXCESSIVE ABSENTEEISM".

WHEREAS, the City of Moline is a home rule unit of government under Article VII, Section 6 of the 1970 Illinois Constitution with the authority to exercise power and perform any function pertaining to its government and affairs; and

WHEREAS, the City of Moline has by ordinance established boards and commissions to assist in representing the residents of the City of Moline and to perform specialized functions; and

WHEREAS, it is the Mayor and City Council determined it is in the best interests of the residents of the City of Moline to establish more specific attendance standards for City boards and commissions.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOLINE, ILLINOIS, as follows:

**Section 1** – The foregoing recitals are hereby incorporated into this Ordinance as though fully set forth in this Section 1.

**Section 2** – That Section 2-4100(e) of the Moline Code of Ordinances shall be amended as follows (additions in **bold and underline**; deletions in **~~bold and strikethrough~~**):

“[...]

(e) Excessive absenteeism. ~~Excessive absenteeism shall mean an absence from more than four (4) meetings of the board or commission during a municipal year.~~ Any appointed member who is absent from more than the number of regular four (4) meetings permitted by this subsection (e) during a municipal year, shall be considered to have resigned from ~~the said~~ board or commission and a vacancy shall exist to be filled according to City ordinance, ~~unless superseded by a board or commission bylaw.~~ Except as hereafter provided, an appointed member may be absent from no more than four regular meetings of a board or commission during a municipal year. Members of the Plan Commission may be absent from no more than eight regular meetings of the Plan Commission during a municipal year. Members of the Foreign Fire Tax Board and the Youth Commission may be absent from no more than two regular meetings of that board or commission during a municipal year. Members of boards or

**commissions which do not have regularly scheduled meetings are not subject to the attendance requirements of this subsection (e)."**

**Section 3 – Superseder.** The specific terms and conditions of this Ordinance shall prevail against other existing ordinances of the City to the extent of any conflicts.

**Section 4 - Effective Date.** This ordinance shall be in full force and effect from and after passage, approval, and publication in the manner provided for by law.


