

# MINUTES MOLINE CITY COUNCIL MEETING City Hall, 619 16<sup>th</sup> Street Tuesday, May 12, 2015

# **Second Reading Ordinances**

# 1. Council Bill/General Ordinance 3020-2015

An Ordinance amending Chapter 4, "ALCOHOLIC LIQUOR," of the Moline Code of Ordinances, by repealing Sections 4-3101, 4-3208(b) and (e), 4-3311 in their entirety and enacting in lieu thereof new Sections 4-3101, 4-3208 (b) and (e), and 4-3311 dealing with the same subject matter; enacting new Sections 4-3312 and 4-3313 and consecutively renumbering the remaining subsections of Division 3; amending the renumbered Section 4-3317; and enacting one new Section 4-3407.

In reviewing the minutes, I think that the amendment regarding the motion was not accurately captured. I had motioned that "someone" be identified as the single point accountable for verifying the validity of the licenses/permits provided by the applicant and Kathy Carr suggested that the Finance Department would be appropriate for that responsibility. Therefore the linance Department was designated in the amended motion for that verification step and the amended motion was then approved. The minutes instead reflect that the amendment was to identify the issuer of the City of Moline's License.

Agenda Items

1. An Ordinance amending Chapter 5, "AMUSEMENTS," of the Moline Code of Ordinances, Article III, "OUTDOOR CARNIVALS AND CIRCUSES," by repealing Section 5-3104 in its entirety and enacting in lieu thereof one new Section 5-3104 dealing with the same subject matter. Kathy Carr. Finance Director, stated that in 2008, the City of Moline implemented an Outdoor Carnival/Circus License to regulate such outdoor exhibitions through licensing and background checks on any person wishing to hold an outdoor carnival or circus within the City. Per the licensing requirements, the personal information required for the background check is name and birth date. Pursuant to a pending application, City staff has reviewed the licensing procedure and contacted other area municipalities and found that none of them require background checks prior to issuing a license for a carnival or circus event. Staff therefore recommends revising the City's licensing requirements by removing the background check requirement. A motion was made by Alderman Parker to approve. Seconded by Alderman Zelnio. Alderman Acri made a motion to add who issues the license and to include volunteers as part of the application information. Seconded by Alderman Liddell. Motion to amend carried unanimously. Alderman Acri made a motion to approve the motion as amended. Seconded by Alderman Zelnio. Motion passed unanimously.
