Second Reading Ordinances

1. Council Bill/Special Ordinance 4008-2018

A Special Ordinance authorizing the Mayor and City Clerk to execute an agreement with the QC Legends Soccer Club to lease the 48th Street Field at Green Valley Park for the operation of a soccer program.

2. Council Bill/Special Ordinance 4009-2018

A Special Ordinance authorizing the Mayor and City Clerk to execute a Lease Agreement with the Quad City Music Guild, for a lease term of April 1, 2019 through March 31, 2039.

Approved: Alderman Parker, seconded by Alderman Wendt, moved to approve Council Bill 1056-2018. Motion carried on roll call with the following vote: ayes: Aldermen Rodriguez, Parker, Wendt, Potter, and Berg. Alderman Schoonmaker abstained due to a conflict of a business relationship.

Aldermen Berg and Wendt expressed enjoyment of recent Water department tours.


Mayor Acri congratulated Community Development Program Manager K.J. Whitley for organizing the annual Volunteer Picnic event.
